#### **TIMES OF SITTINGS**

- The Court of Chief Pleas will take place on the 1st October 2017.
- The Royal Court (Commercial / Ordinary Court) (Jurats business) will sit at 10.15a.m. on the dates set out below.
- The Royal Court (Full Court) sits at 9.30am on the dates set out below.
- The Ordinary Court (Bailiff's business) will sit every Friday at 9.30am followed by Interlocutory business.
- The Royal Court Matrimonial Causes Division will sit unrobed at 10.15am on the dates set out below to consider all matrimonial matters (including judicial separation applications by consent).
- The Royal Court Criminal Division will sit robed at 2.30pm on the dates set out below for Plea and Directions Hearings. Counsel and defendants to be present at 2.15pm.
- The Royal Court Criminal Division will sit from 9.30am to 12.30pm and 2.30pm to 4.30pm on Monday, Wednesday and Friday, and from 10.15am to 12.30pm and 2.30pm to 4.30pm on Tuesday and Thursday during Criminal Trials and Appeals weeks.
- The Contracts Court sits every Tuesday and Thursday at 9.30am except for 3<sup>rd</sup> April 2018 (Tuesday after Easter) and Tuesday 25<sup>th</sup> December 2018 (Christmas Day).
- The Royal Court vacation, during which Court hearings will be kept to a minimum, will run from 30<sup>th</sup>
   July to 31<sup>st</sup> August 2018 inclusive (Criminal Division & Civil Division).
