### TIMES OF SITTINGS

- The Court of Chief Pleas will take place on the 30<sup>th</sup> September 2019.
- The Royal Court (Commercial / Ordinary Court) (Jurats business) will sit at 10.15a.m. on the dates set out below.
- The Royal Court (Full Court) sits at 9.30am on the dates set out below.
- The Ordinary Court (Bailiff's business) will sit every Friday at 9.30am followed by Interlocutory business.
- The Royal Court Matrimonial Causes Division will sit unrobed at 10.15am on the dates set out below to consider all matrimonial matters (including judicial separation applications by consent).
- The Royal Court Criminal Division will sit robed at 2.30pm on the dates set out below for Plea and Directions Hearings. Counsel and defendants to be present at 2.15pm.
- The Royal Court Criminal Division will sit from 9.30am to 12.30pm and 2.30pm to 4.30pm on Monday, Wednesday and Friday, and from 10.15am to 12.30pm and 2.30pm to 4.30pm on Tuesday and Thursday during Criminal Trials and Appeals weeks.
- The Contract Court sits every Tuesday and Thursday at 9.30am except for May 9<sup>th</sup> (Liberation Day) and December 26<sup>th</sup> (Boxing Day).
- The Liquor Licence Court will sit every Tuesday at 9.45am following Contract Court.
- The Guardianship Court will sit every Thursday at 9.45am following Contract Court.
